COVID 19 AND AYUSH, IN SEARCH OF A SHAKTI OR A SANJIVANI

THE MONSTER

The peril of CV-19 has practically been felt by every individual on planet earth and more poignantly in the country and the society in which one lives. It has turned out to be a mammoth monster for humankind rather than a medical predicament/problem. It is truly akin to war on an unprecedented scale against a poorly defined enemy where the right weapons to either restrain or destroy have yet to emerge.

The Indian battle after initial gains has become even more threatening. Deployment of all resources in full strength must be envisioned. Much more than what one can absorb is now becoming known about CV-19 with one singular outcome. CV-19 is thus hugely complex and the outcomes are unclear with this monster evolving everchanging contours. If so, it is necessary to look at this scourge of humankind with different insight.

In India AYUSH has rightly taken on the challenge of playing its role. Challenges and opportunities are still in waiting. While the battle is on, there are always reasons for course correction and evolution of newer strategies and more importantly, the wisdom to learn from experiences

thus far. In my earlier *PreNotes*, particularly in the April-June 2020 issue I had covered several aspects; including needs, the approach and caution to be adopted.

WHAT HAS HAPPENED OVER THE LAST YEAR?

There has been a lot of noise with regards to an increased awareness of Ayurveda, Unani, Homoeopathy, Siddha and Yoga. Efforts have been made and activities initiated. The Government offered full support to AYUSH and has been extending it further, in search of a solution. With 100s of webinars, 100s of experts, 100s of solutions, and 100s of products, the situation is as yet confusing and the role of AYUSH is unclear or perhaps charitably speaking, it is stated to be complementary and has been proposed as being palliative, as usual. This, despite the fact, that modern medicine's claims to have defined it for possible preventive or therapeutic solution has neither a clear understanding of the disease or the disease behaviour nor has it succeeded in scientifically validating one or more specific aspect of the disease beyond doubt. Industries of practically every possible hue and colour including pharma, medicinal equipment and Ayush have seen abnormal growth under the opportunistic shield of

immunity. The science of immunity is being deduced in every possible way whether relevant or not. Science will need to chase 'immunity' further for its cause – effect relevance.

As one learns of nearly 100 + different types of proposals under AYUSH, the chances of concrete outcomes seem limited because of restrained and poorly targeted efforts. Scattered, diffused and diverse efforts to deal with a monstrous disease are bound to result in unclear outcomes and create more confusion in the minds of the profession and the people. The frustration of the AYUSH profession at the ground level is obvious with individuals, groups and some industries making valiant efforts and struggling to find a way. Unfortunately, these efforts will be wasted if not streamlined.

As we eagerly await the outcomes of the multiple activities that were undertaken, some of the results that have been shared, require a studied review of our approaches.

AYUSH 64

In the 1980s AYUSH 64, an Ayurvedic product developed by CCRAS was offered through NRDC to five companies as Anti-Malarial with 65+ % success rate in comparison to Chloroquine. ZANDU was one of the first five companies with its own process of aqueous extraction – similar to *Sudarshan Ghan Vati* – and adhering to the suggested standards, introduced it as Chirakin. The idea had originated from the most commonly used *Sudarshan Ghan Vati* used as *jwaraghna* (used in fevers) where *Swertia chirata* is the main half of the polyherbal formulation.

Ghan - aqueous extracts of Saptaparna - Alstonia scholaris, Kutaki - Picrorrhiza kuroa and Latakaranj -Caesalpinia crista are indicated for a variety of fevers in Ayurveda. Large scale production of multi-ingredient aqueous extracts – ghanvati – is not easy as commonly believed but requires a skilled process control, managing water and the temperature. I was witness to the different aspects of the development when Chirakin was introduced as a prescription product. However, the prescription market did not find much favour with Ayush-64 in comparison to chloroquine which was found to be more potent while Sudarshan Ghan Vati which was sold as a PTC [over-the-counter] product, being more effective, grew substantially as it was liked both by the profession and the people. Interestingly, though the standardization of Sudarshan Ghan Vati with many ingredients was considered challenging, many people rely on it and it continues to grow even now after five decades!

The choice of Ayush-64 therefore for CV-19 appears to be based on its effectiveness - though lesser - in

comparison to chloroquine! The clinical research for CV-19 it seems was designed to be complementary from the beginning. With the choice of the quinine derivative which is not a known solution for CV-19 as a control choice in mild to moderate cases and investigating it for limited benefit over a longer - 2-to-12-week period, seems to have marginalised the role of Ayush-64 in CV-19. Here, though helpful like several other remedies the question of innovation or looking for a new integrated solution to CV-19 does not arise.

Developing and designing a product or a drug based on Ayurveda without a thorough understanding of the Ayurvedic nuances of the disease and the principles of understanding the ingredients, their compositions or synergies is bound to fail by simply imitating and borrowing incorrectly applied scientific tools.

This is when sincere research efforts in the right direction will not only help provide simpler and yet clinically relevant understanding of the CV-19 but also provide therapeutic rationale with optional clinical choices as well. The language, the paradigm of Ayurveda, might be different but is comprehensively logical and explainable to the aim and can provide much needed relief to suffering humanity, if not a full cure. There exists even potent possibilities with sincere efforts for fundamentally integrative and novel modalities to scientifically probe even the curative aspects and thus develop product/s.

The experts concerned must accept that the monster as is known currently, is a consequence of the complexity of science and obviously there is a need to search for alternate scientific means and methods to curb it. It is therefore necessary to come out of a tangential or exploitative approach to AYUSH systems. There is enough science available now to realign and reconfirm with AYUSH principles and practices having clinically simplistic acumen that have potentials to take on the therapeutic challenges.

Huge data, planned or otherwise, on CV-19 must have been generated and is accessible. There is a need to examine this data beyond the standard epidemiological approach with an AYUSH viewpoint to examine the disease in its totality - cause, symptomatology, disease progression and responses to the variety of preventive curative treatments. Additionally, measures or employing a mechanism to derive critically screened observations and learning of ground experiences by executors of the proposals and practitioners, can provide useful insights to better address the disease. There is an equally imperative need to look into the standardization of offerings, products or therapies, for preventive, supportive or curative purposes. This will help remove

prevailing confusion.

Ayurveda has much to offer but the nuances of their composition, therapeutic rationale and processing are important. Developing a few, selected Anti CV-19 product/s based on AYUSH principles to address different stages or aspects of the disease and considering the potentials of Ayurvedic ingredients or combinations including at least one *Rasa Aushadhi* for severe cases could be the approach. Efforts have already been made and as suggested in several groups need to be further strengthened with well-defined therapeutic targets in coordination with the academia and the industry for larger acceptance.

AYUSH awareness has happened but lack of means of reliability for the consumer and the patient will harm the gains. Let not the opportunity to bring all together - academia, profession, researchers and industry – be lost. This must be done on the AYUSH paradigm by the AYUSH fraternity to ensure that the same advisor experts must not be allowed to point fingers at AYUSH being non-scientific. *The fact is that Ayurveda is right.* Science is right. The question is only how can one use the science for Ayurveda?

The administration must own its mandate towards the AYUSH sector and its inherent strengths. It must be sensitive to the long-term damage in the form of loss of

credibility of the systems. It cannot fail the trust placed in it by the people and the government, particularly the Prime Minister who has great expectations. It should not allow itself to be a second fiddle in the hands of those who neither wish to understand the depths of AYUSH systems nor do they know how to use the science beyond their narrowed or blurred vision. Most of these big named experiments with similar approaches have failed to contribute even an iota to the AYUSH systems or to the sector or the profession or the academics or even to the science.

In the epic Mahabharat, *Mritunjaya* Karna had no choice but to use the one and only singly used *Vasavi Shakti* obtained from Lord Indra to kill Ghatotkach, the elusive warrior who had killed seven *akshauhini*, more than 15 lakh enemies. While the world and we may continue to look for an elusive shakti with all the discipline, dedication and benevolence of Karna we can also rely on *Amrita* (*Tinospora cordifolia*), giver of life as the name denotes that Indra only showered over Laksmana and hundreds of soldiers to regain consciousness to fight the battle.

There is Acceptance and Unprecedented HOPE for The Common Person. AYUSH has the opportunity to take on the challenge with change in its course of action.

OBITUARY Prof. Dr. A. J. Baxi

Dr. Prof. Dr. A. J. Baxi, member of our National Advisory Council (NAC) was the former Head of Pharmaceutical Division, IPGT&RA, Gujarat Ayurved University, Jamnagar. He was Chairman of International Ayurved Foundation (India Chapter) and Consultant to Government of Sri Lanka on Ayurvedic Drug Standardization. He has established preliminary Analytical standards for more than 800 classical drugs and formulations. During his 25 years at Gujarat Ayurved University (GAU) he developed analytical methodology for establishing standards and purity of classical Ayurvedic drugs and formulations.



Prof. Dr. A. J. Baxi

Dr. Baxi was a recognized resource person of IGNOU. Prof Baxi re-joined GAU under the stewardship of Dr. P.N.V. Kurup, endeavoured as a Dean, to establish the first ever Institute of Ayurvedic Pharmaceutical Sciences, offering D. Pharm (Ayu), B. Pharm (Ayu) and M. Pharm (Ayu) courses. He was always identified with integration of sciences and our heritage of Ayurvedic Knowledge. He was on forefront of such integration.

Dr. Baxi was an unsung hero, committed worker who influenced lives of many students and scholars without making it obvious. He was a quiet man who believed in and was committed to efficiency of his work. IASTAM Shri Gopaldas Parikh Awardee 2018, he always helped and supported IASTAM and its activities.

His visit to Mumbai and meeting with Mr. Praful Patel helped with interesting interaction. He tried his best and took the initiative to institute an Award in the name of Rajvaidya Bawabhai Achalji. When that did not materialise, taking a step forward personally, he expressed faith in our activities and capabilities by donating Rs. 50000/-. He had personally sent IASTAM Text Flyers with personal recommendation. His review about the book was amongst the initially received.

His demise is a great loss to Ayurved fraternity and IASTAM activities.

REMEMBRANCE

Dr. S. K. Jain

Internationally renowed Ethnobotanist, Dr. S. K. Jain, Scientist – Emeritus, National Botanical Research Institute and Hon. Director, Institute of Ethnobiology, played diverse roles in developing IASTAM. Dr. Jain was a great pillar to IASTAM and 4 President of IASTAM - India.

Dr. Jain was a former Director, Botanical Survey of India, and National Environment Fellow. He had worked as Project Investigator of numerous Indian and foreign projects. He was conferred the prestigious Distinguished Economic Botanist Award. Dr. Jain with his pioneering work was known as the 'Father of Indian Ethnobotany'. His book 'Dictionary of Indian Folk Medicine

and Ethnobotany' was presented as evidence in US court to win India the patent of 'haldi' (turmeric).



Dr. Jain founded the Institute of Ethnobiology, Gwalior later renamed as SK Jain Institute of Ethnobiology in his honour. Twenty-five new plants have been named after him (Jain) [e.g. Jainia, Saussurea sudhanshui]. He also founded the Society of Ethnobotanists and Association for Plant Taxonomy and initiated journals of these societies. He was the Vice President of IASTAM since 1982 to 2005 and then the President for one term. He had participated at the International Congress of Traditional Asian Medicine at Canberra where the idea of establishing IASTAM was initiated. The key-note address presented by Dr. Jain, at the ACTAM, in 1983 in Mumbai and other conference organised by IASTAM were a virtual intellectual feast for the audience. Enthusiastically he had published a review of the IASTAM Proceedings 2005 'Transforming Traditions for Tomorrow's Health' in Indian Journal of Traditional Knowledge. IASTAM had received his valuable inputs in revising the IASTAM



ABOUT PHARMACO-VIGILANCE

Recently IASTAM was actively involved in a joint webinar on Pharmaco-vigilance for AYUSH Products with fruitful deliberations. Following that, in an interesting internet search I was surprised to learn of penalties worth US \$ 38.6 billion (Rupees 2847,87,51,90,000/-) levied over 27 years in the USA, one of the most well-regulated countries. In India on the other hand, a country that boasts of being one of the largest pharma industries in the world over many years under CCI, it was found to be Rs. 74 crores only; as most of the other adverse drug reaction (ADR) data had not been well documented or made available! Even if one can access more of the data on penalties it would not be significant. This is in reference to the reporting in one paper of Yograj Guggulu for its moderate reversible side effects despite it not being administered as per Ayurveda and aggressively being referred to, again and again. Whereas I am fully in favour of the use of certain Ayurvedic preparations under professional supervision only and regulating the sale of one and all products under the name of AYUSH I do wish that the AYUSH fraternity would address the issue of convenient and dogmatic misuse of science for its right perspective. AYUSH pharmaco-vigilance must be developed on its own premise.

Furthermore, for those interested I would strongly recommend the book 'Bad Pharma: How Medicine is Broken, And How We Can Fix It' by Ben Goldacre (2012) that addresses the evil and potential hazardous aspects to humankind of instances of clinical research and methods followed for their publications in high indexed journals!
