PRE NOTE

Minamata Convention and its impact on availability of Mercury for AYUSH Sector

Dear friends, best wishes for Happy and Prosperous New Year 2022.

Following law of nature one more year has passed with its happy or sordid memories and we are ushering in new year 2022 with lot of possibilities and expectations.

You are having new issue of IASTAM News Letter, first to be produced by Dr Vidhi Bapna as Editor with new Board of Advisors Chaired by Dr N S Bhatt, Former President IASTAM.

In this first issue of 2022, we wish to draw your attention to Minamata Convention mandating Mercury Free **World** by 2020 by 137 countries. India also signed the consent in 2014 and entered the Convention from 2018.

With the singing of Minamata Convention, existence of Rasa Shastra and Rasaushadhis have been grossly endangered. Understanding the gravity of the situation all the stakeholders including AYUSH industry and Academia joined hands and submitted multiple representations to the Ministry of AYUSH along with the Ministry of Environment and Forest and Climate Change (MoEF CC), Govt of India. AYUSH industry shared the importance of Mercury for Ayurveda highlighting the fact that 30% to 40% of approximately 1.5 lac formulations in TKDL have mercurial compounds and after 19th Century more than 60% of formulations contain Mercury or Mercurial Compounds as ingredients. Academia simulated the importance of introduction of Mercury in Ayurveda in 11th Century AD with the introduction of Antibiotics in modern medicines centuries later.

The representations drew the attention of the MoEF CC to the possibility of continuous use of Mercury under exclusion for products used for "Traditional or religious practices" in Annexure 'A' of the text of Minamata Convention dated 31.07.2013 under United Nations Environment Programme (UNEP). Ministry of AYUSH also emphatically highlighted this point. However, it is not clear, whether the Ministry of Environment and Forest and Climate Change have yet provided any assurance of continued supply of Mercury to AYUSH industry in writing.

Few of the importers of Mercury got notice from DGFT (Director General Foreign Trade) informing change of status of Mercury from "Free" to "Restricted Category" along with the detailed proforma to be filled up and submitted as part of PIC (Prior Informed Consent) document.

In the meantime, Ministry of AYUSH circulated "The guidelines for environmentally sound storage of Mercury contents, environmentally sound management of Mercury waste" from the Ministry of Environmental of Forest and Climate Change for compliance by all ASU Drugs manufacturers. The guidelines provided the infrastructure related requirement for storage, processing and disposal of Mercury. The same guidelines have been referred to in the proforma shared by DGFT also, having requirement of NOC from State Pollution Control Board.

AYUSH Industry appreciates the concerns of Minamata Convention for protection of Environment from Mercury, however, it is important for MoEF CC and Central Pollution Control Board to provide Standard Operating Procedures (SOPs) and detailed guidelines to be followed and hand holding to ensure environmentally sound storage, processing and disposal of Mercury during manufacturing of Rasaushadhis.

Ministry of AYUSH should also consider extending financial support to industry to ensure the same and request organizations like NEERI of CSIR to come forward to help the sector to continue manufacturing Rasaushadhis in full compliances of international obligations.

Coming back to IASTAM, it gives me pleasure to inform that we have got enthusiastic response to invite nominations for IASTAM Awards which, over the time have assumed status of "coveted". Need cooperation of all of you for successful IASTAM Conclave on the theme of "Targetted Therapeutics and Ayurveda" and Award Function probably towards end of Feb 2022 depending upon the prevailing situation arising out of Covid 19 pandemic.

Dr. Satyavati's reverence to the guru and contributors in her life not only reflects in her communications but has materialized into several acts of charities for the activities dedicated to their memories. Personally, interactions with her – at times even argumentative - have always been of learning and inspiring. I was strongly influenced the very first time when I saw her at a conference on stage with protective arguments for precinct of Ayurveda as against dogmatic behavior of a well-recognized modern medicine expert. Her point was clear, either you convince me or accept my view, I will not accept ambiguous statements on subject that you pretend to have mastered! Incidentally,

after some years, I also ended with similar argument with the same expert. There were several such occasions thereafter to witness her honesty, commitment, fearlessness and above all faith in Ayurveda.

With utmost faith in Ayurveda, striving for its scientific outlook and rising through the rigors of medical research to become Director General of Indian Council of Medical Research [ICMR] and that also adhering to the principles she believed in was definitely a mammoth mission. That reminds of an article she wrote of her own 'Agony & Ecstasy' about Ayurvedic research in a very similar manner that Irwing Stone the original biographer-author of 'The Agony & the Ecstasy' must

have imagined in life of the world-famous sculptor Michel-Angello. Living a life on own terms - with an honest commitment to one's belief and endlessly work for that belief - irrespective of consequences comes naturally to a karmayogi. The life of Dr. Mrs. Satyavati lived with an equanimity symbolizes karmayoga.

I have been fortunate to get her support and suggestions for shaping of IASTAM. She had shared a detailed visionary idea for an 'International academy of Ayurveda' committed to highest standards of professionalism and showed her trust in me to lead it through IASTAM; but its size and scale as I visualized were too huge. Hope, in coming times the sector will see that happening.

PROMOTING SCIENCE FOR SOCIETY: CHOOSING NEWER ROLES AND RESPONSIBILITIES FOR PROFESSIONAL ORGANISATIONS

A 'scientific professional society' is loosely defined as a congregation of people having common interest of progressing in a specific technological or scientific area and to facilitate the interaction of interested people on a regional, national, or international level. We see that the 'common interest' and 'catchment area' are two conspicuous boundaries of any scholarly society (1). We will expand here the conventional idea of scholarly society in context of IASTAM and will see how it can take maximum leverage while working inside its professional boundaries.

Indian Association for Study in Traditional Asian Medicine (IASTAM) is seemingly the first Indian association related to traditional medicine having its delivery across the nations. NGOs / societies, organisations and associations play a crucial role in the progress of health care science and making them useful to the people. Obviously in the current era where physical boundaries between nations have ceased to exist and when distances have become immaterial for scientific debates, any such organisation can expect much more than it had visualised. What in general it needs is to recognise its strength and subsequently to find the ways to utilise it optimally, effectively and efficiently. Besides the five important roles the associations are generally imparted for namely: communicating with peers, research promotion, dissemination of science, representation of professional interests and policy advice to authorities (2) one important addition seems to promote cross system

dialogue in order to promote cross disciplinary research exchanges.

Objectives of IASTAM are well drafted and defined. Much of the functioning of IASTAM is actually in tune to the 'ten simple rules for forming a scientific professional society' (1). These objectives however are needed to be re–read not in context of what the organisation aims to achieve but also in context of what it wants to deliver in terms of how and when?

Without looking at each objective of IASTAM in detail and then to see how its impact can be maximised, we are putting here a few key areas which are needed to be focused for overall growth of Traditional Asian Medicine (TAM) and where IASTAM may play decisively. This would not be out of context to put here that TAM actually makes the most of traditional health care practices observed globally and hence making it better served would eventually help nurturing the TM in whole.

The first priority in TAM research should now be about Comparative Effectiveness. This comparative effectiveness (CE) should necessarily be established within system for variety of interventions and also across the systems for diversity of approaches and their dependable benefits. This step is likely to be foundation of a globalised standard health care based upon differences of the systems meaningful in terms of various real life clinical situations. The enforcing idea of CER should not be to undermine or position any system under or

above the other but to see their uniqueness in context of variable needs of a patient and dependable deliverables which a system may offer. Being a conglomeration of all TAM practices across the continent, IASTAM becomes a natural choice to take this responsibility of leading in this direction. We propose that IASTAM may form some small secretariats pertaining to various TAM systems under its central management. This will help filtering the people on the basis of their system and research expertise and will help connecting the people working in similar areas.

The second important functioning IASTAM may impart is to emerge as a facilitator for numerous budding researchers still looking to be nurtured to grow to their fullest potential. Having a pan Asian network of eminent scholars from variety of fields representing TAM, IASTAM can easily build a pool of mentors willing to help new researchers for the optimisation of their researches. This will expand the reach of organisation to young generation which somehow currently feels that this is an organisation of eminent scholars where they cannot find a place.

Besides intersystem research, cross disciplinary researches are gaining momentum now. Such cross disciplinary researches are between the health care system and other branches of science helping to understand traditional science in a more logical manner. Ayurveda biology was conceived to see how Ayurveda can be looked from the biological perspective and vice versa. Similarly the idea of Ayurveda physics to explore various physical therapies used in Ayurveda and Ayurveda chemistry to explore the chemistry of Ayurveda formulation and pharmaceutics can be picked. IASTAM can take-up the task of interdisciplinary researches by

joining hands with other professional bodies having expertise in other areas of science to see how this can help exploring Ayurveda to newer heights (3).

Focused approach and dedication often brings more gratifying results than those based upon the resources alone. There are few organisations in Ayurveda who have set examples of excellence in focus areas despite of their resource limitations (4). IASTAM is one among those few. In this decade of functioning of IASTAM eventually leading to mark its half century, more is expected from this prestigious organisation. Let us work together and united to bring out more from the TAM having real and clear value for the society.
